LONG TERM FORECAST

ONE IN FIVE THUNDER BAY DISTRICT RESIDENTS IS ALREADY OVER 65, AND ACCORDING TO THE NORTH SUPERIOR WORKFORCE PLANNING BOARD, THOSE AGING OUT OF JOBS AREN'T BEING REPLACED QUICKLY ENOUGH, DESPITE PROGRAMS DESIGNED TO REPLENISH THE WORKFORCE.

CANADA'S CONSTRUCTION INDUSTRY WILL NEED TO FILL MORE THAN 300,000 VACANCIES OVER THE NEXT DECADE, ACCORDING TO NEW RESEARCH, AS WORKERS RETIRE AND DEMAND INCREASES. THE INDUSTRY WILL NEED TO LOOK TO IMMIGRATION MORE THAN EVER BEFORE TO PLUG LABOR GAPS CAUSED BY CANADA'S AGEING POPULATION.

TO SUPPORT THE RECRUITMENT AND RETENTION OF SKILLED FOREIGN WORKERS IN NORTHERN ONTARIO, THE FEDERAL GOVERNMENT INTRODUCED THE RNIP PROGRAM IN 2019. THE PROGRAM IS DESIGNED TO SPREAD THE BENEFITS OF ECONOMIC IMMIGRATION TO SMALLER COMMUNITIES BY CREATING A PATH TO PERMANENT RESIDENCE FOR SKILLED FOREIGN WORKERS WHO WANT TO WORK AND LIVE IN THE THUNDER BAY REGION.
