LONG TERM FORECAST

One in five Thunder Bay district residents is already over 65, and according to the North Superior Workforce Planning Board, those aging out of jobs aren't being replaced quickly enough, despite programs designed to replenish the workforce. A report by the NSWPB, projected the Thunder bay district would need 50,000 new migrants by 2041.

According to a new survey by Statistics Canada, nearly two-thirds (64 per cent) of businesses in accommodation and food services said they would face labour shortages in the next three months - the largest proportion across all other sectors.

To support the recruitment and retention of skilled foreign workers in Northern Ontario, the federal government introduced the RNIP program in 2019. The pilot is designed to spread the benefits of economic immigration to smaller communities by creating a path to permanent residence for skilled foreign workers who want to work and live in one of the participating communities. The RNIP program makes the process simpler, and provides the employer flexibility to hire workers for various teer levels across various industries.
